

#### **INTRODUCTION**



The feedback collected from the individuals has been analysed and taken to the consideration for the development of curriculum, teaching learning process and environment.

#### STUDENT FEEDBACK REPORT

The Students' Feedback on curriculum and teaching learning process at the oxford college of pharmacy, Bangalore campus is designed to get formative feedback from students that can be used towards the improvements in the quality of course design and delivery, as well as student learning experiences. For the academic year 2020-2021, students' feedback is sought from around203students about the curriculum and teaching learning process. Majority of the students strongly agreed that the syllabus is covered by the teachers on time. Around 96.1 % - of the students agreed that curriculum provided the right knowledge of theoretical practical experience. It is observed that 96.1 % of the respondents agreed that the sufficient material and related text books and other resources are available in library for the topics mentioned in the syllabus. The students' feedback revealed that 50.7 % of them agreed and 41.9 % strongly agreed to the point that teacher pay attention to academically weaker students as well. Also, majority of students (95.1 %) agreed that the curriculum satisfies the industry requirements and has provisions for professional development.




# The teachers explains the topic effectively 203 responses




Sufficient material and related text books and other resources are available in library for the topics mentioned in the syllabus




Do you think the curriculum provided the right knowledge of theoretical and practical experience? 203 responses




### Curriculum satisfies the industry requirements and has provisions for professional development <sup>203</sup> responses



# The teacher pays attention to academically weaker students as well <sup>203</sup> responses




# How organized was the course in terms of time frame, assessment and access to materials? 203 responses




#### TEACHERS FEEDBACK REPORT

Feedback on various aspects of curriculum is sought from -faculty members of oxford college of pharmacy. The aspects such as provision of adequate time and resources for framing syllabus, coverage of both theoretical and practical components in the syllabus, the coherence of the syllabus with Programme Outcomes, involvement of the field experts while designing the syllabus, focus on necessary technical/ teaching skills, ensuring components that inculcate ethical values, enlisting reference books, focus on flexible curriculum based on current trends, updated elective courses etc. As teachers play a pivotal role in designing and implementing the curriculum, the inputs received from their feedback was taken into consideration for further necessary action wherever applicable. Majority of the teachers are agreed that aim and objective are well-defined to teacher. Majority of 52.9% of them agreed and 47.1% of them strongly agreed that pedagogy proposed in the curriculum matches the contents. It is observed that 58.8% of them strongly agreed and 41.2% of them agreed curriculum is balanced with regard to the theoretical and practical knowledge. It was noted that 47.1% and 52.9% of the respondents strongly agreed and agreed to the syllabus is related to the subjects.




### Pedagogy proposed in the curriculum matches the contents






#### Syllabus is contemporary and need based




### Whether sufficient hours allotted for the topics?




### Whether the framed syllabus is related to the subjects?



#### Whether curriculum development procedure needs improvement?





#### **ALUMNIFEEDBACKREPORT**








#### Availability of reference books




### Overall academic atmosphere in the college






# Career orientation program conducted related to the syllabus 36 responses
