The Oxford College of Pharmacy in Bengaluru organized the PHARMA ANVESHAN 2025 on Wednesday, 6th March 2025, to mark the 123rd birth Anniversary of Prof M.L. Schroff, the Father of Pharmacy Education in India.

The basic objective of this event was to encourage and promote students, faculty, and staff members to pursue innovation and entrepreneurship, to create enabling policies, and foster an ecosystem to generate ideas across disciplines that can be transformed into successful innovative technologies, products, and services as well as to establish a mechanism for technology development and technology transfers. The program started with a prayer song by our students, followed by lighting the lamp. All the Delegates from various industries and academic institutions students are welcomed by our beloved Principal, **Dr. Parthasarthay G**. Before welcoming, the Principal appreciated that **Honourable Dr. Montu M Patel, a young and dynamic leader** who has thought about celebrating the birthday of Prof M L Schroff and thanked the president for selecting our college to conduct this Pharma Anveshan 2025. The eminent personalities **Dr. S N V L Narasimha Raju, Chairman, The Oxford Educational Institutions, Dr. Ramachandra Setty, Director R&D, RGUHS, and Dr. M.Niranjan Babu Central Council Member, PCI,** addressed the gathering in the inaugural program. All these eminent personalities expressed how to build the nation through an innovation-led entrepreneurial ecosystem for supporting pharmaceutical innovation and nurturing start-ups in India with the goal of positively impacting human health and well-being.

All these people's addresses revolved around the **theme ''Entrepreneurship & Startups in Pharma and Pharmacy Practice —Encouraging Innovation, Incubation Centers and Pharmaceutical Startups''**. They also stressed educating overarching guidelines for creating nationwide innovation & entrepreneurial framework and considering entrepreneurship as a preferred career with helping and creating a larger number of sustainable start-ups in the pharmaceutical domain towards impactful social benefits.

Dr. M. Niranjan Babu, a **Central Council Member of PCI in New Delhi**, shared his thoughts on Pharma Anveshan 2025. As a distinguished personality in pharmacy education, his insights on the event will likely be significant. Organizing events like Pharma Anveshan is crucial to honoring the legacy of pioneers like Prof. M.L. Schroff and encouraging the growth of pharmacy education.

Dr. M. Niranjan Babu's talks gave insight into various aspects of innovations with translational outcomes in the pharmaceutical sector, which had been challenging in the past due to the rigors of academic careers, milestones for faculty and institutions, and limitations arising from financial concerns or mistrust of developing partnerships with

the industry. However, in the current scenario, innovation is now becoming the fourth pillar of academic pharmaceutical excellence. It is, therefore, imperative to develop a holistic ecosystem where faculties/students and staff can be more effective innovators and translate their solutions for beneficial impact on society. He also shared that the Pharmacy Council of India has selected two colleges from Karnataka state to sponsor Pharma Anveshan 2025, and one of those colleges is The Oxford College of Pharmacy.

Dr. Ramachandra Setty, Director of R&D, RGUHS, emphasized innovation in all facets that impact the creation and functioning of the national pharmaceutical system. He highlighted innovations in Public health delivery systems, Healthcare Business Model Innovations (including digital healthcare delivery systems), and category-specific innovations such as those pertaining to Pharmaceuticals (Active pharmaceutical ingredients (APIs), Repurposing of the drug candidates, Modified drug delivery systems and Biosimilars), Nutraceuticals, Vaccines, Diagnostics, and Medical Devices (including healthcare software systems and health and wellness mobile apps as medical devices) and inter-disciplinary innovations.

Dr. Setty also spoke about the scope of the current policy framework, which also includes diagnostics, medical devices, healthcare IT, online pharmacy, personal health management, home healthcare, telemedicine, biotech R&D, genomics, and biopharma. Currently, start-ups in the country operate in one of these verticals. They are using Artificial Intelligence or Machine Learning and other modern technologies to improve the quality of healthcare, access, and affordability.

Overall, both guests emphasized the continuum of innovation and entrepreneurship in accordance with the existing national innovation and start-up Policies, potentially in view of the prevailing therapeutic/clinical needs in the pharmaceutical sector.

Dr. S N V L Narasimha Raju, The Chairman of The Oxford Educational Institutions, emphasized the importance of industry participation in the curriculum. He urged all participants to take a moment to pay homage to **Prof M.L.Schroff** on his birth anniversary, highlighting the significance of honoring those who have made significant contributions to the field of pharmacy.
